The construction contract is the starting point for the building project. In Germany, the regulation of the project can be based on the German Civil Code (BGB) or the framework within the German Construction Contract Procedures (Vergabe- und Vertragsordnung für Bauleistungen - VOB).

What are the requirements for a construction contract in Germany?

Under German law, forming a binding contract requires only two elements: an offer; and the corresponding acceptance. Construction contracts are not subject to any specific requirements as to their form, and may even be concluded orally. Only the consumer construction contract requires a written agreement (section 650i (2) BGB).
