What is the warranty on BMS products?

All BMS products have a 90-Day Limited Warranty. Any defective product must be returned to BMS with an itemized receipt as proof of purchase. Limited Warranty applies only to products that are returned within 90-days of the in-store purchase date. If a product is deemed defective by BMS, the customer will receive a replacement product.

What is the warranty period for the battery pack?
