Are Ottawa's new battery energy storage rules too far?

A city committee passed new regulations Thursday that lay out the ground rules for companies looking to build battery energy storage facilities in Ottawa, but residents are split on whether the new rules go too far -- or not far enough.

How will a battery storage project benefit Ottawa?

The battery storage project alongside the six solar projects Council supported earlier this fall will reduce the city's reliance on expensive gas-fired electricity during peak demand and strengthen Ottawa's ability to meet its climate and energy commitments.

Can a battery facility be built in Ottawa?

According to the new rules, companies looking to build a battery facility will have to show Ottawa Fire Services (OFS) that effective fire and safety risk management has been incorporated into the design. Companies will be required to install fire prevention and suppression systems, and provide OFS with site-specific training.

Will Ottawa City Council approve marchurst battery storage zoning?

"Ottawa City Council's approval of the Marchurst battery storage zoning is a strong and welcome step in our local energy-transition journey, but it is only one step.

Facilities that successfully demonstrate their capabilities will be contracted by mid-2024, with operations starting on or before May 1, 2028. The Ottawa BESS 2 Project, among other electricity storage sites, ...

The project can store 250 MW of electricity, making it the largest battery energy storage system proposed in the Ottawa area so far. A 250 MW battery can supply enough power at one ...
